- The participant must share a video up to 5 minutes. Participants can select a song of their choice from the following genres: Traditional Jazz, Contemporary Jazz, Latin Jazz, Jazz rock and Fusion.
- The performance recording must be shot on video with a single camera, in a one take, live performance only with no edits. The video frame must show the entire performer, i.e. the whole person and the whole bass. No hand close-ups permitted.
- The video performance, a completed copy of this application form, the Release Authorization MOD B, and a copy of relevant identity documents must be sent by email to [virtuoso@markbass.it](mailto:virtuoso@markbass.it) to enter the contest, with the subject line: **"Markbass Virtuoso International Contest.**
- Registrations are open from August 10<sup>th</sup> to September 10<sup>th</sup> 2023 (Inclusive).
- A special Jury composed of industry experts and professional bass players (all the details are within the Complete Regulation document) will decide the winners: first, second and third places will be awarded with special prizes.
- The first-place winner will be Markbass' guest for the award Ceremony will be held in Pescara on October 8<sup>th</sup>, the winner will open for Alain Caron's concert on that day with their winning song.
